Dear Prof. Moisseiev,

Following the presentation delivered during the December 3rd, 2025, webinar on **eyePlate-S** by one of the KOLs, we became aware of strong reactions from some Israeli ophthalmologists regarding perceived political messages embedded in the presentation slides. **Rheon Medical, and I personally, sincerely regret that this situation arose.** We, at Rheon Medical, firmly believe that scientific exchanges should remain strictly focused on science and clinical evidence.

As CEO of Rheon Medical, I would like to:

- a) clarify the nature and organization of the webinar,
- b) clearly state the mission and policy of our company, and
- c) outline measures to prevent similar incidents in the future.

a) Nature and organization of the webinar

Rheon Medical organized this webinar to present the broader glaucoma surgeon community with the latest clinical evidence on the newly approved **eyePlate-S**. We believe this technology offers meaningful benefits to glaucoma patients in terms of safety and performance, and to surgeons in terms of procedural control and ease of implantation.

To meet the objectives of the webinar, we invited highly experienced KOLs with substantial clinical exposure to eyePlate-S. In line with our strict ethical and business standards, Rheon Medical:

- did not provide any financial compensation to the participating KOLs, and
- did not request prior review or approval of their presentation content or slides.

Rheon Medical did not interfere in any way with how the moderator or KOLs presented their work or addressed questions. Rheon Medical team members participated merely as attendees, and we became aware of the presentation content for the first time during the live webinar.

b) Mission and policy of Rheon Medical

Rheon Medical's mission is to develop innovative technologies that improve the efficacy of glaucoma treatment and, ultimately, patients' quality of life. We operate under strict ethical standards across all aspects of our business.

Rheon Medical has no political affiliations or inclinations. Our mission is fundamentally humanitarian in nature, and we do not take, promote, or support any political positions. We are committed to keeping our business activities and all public communications entirely free of political connotations.

c) Measures to avoid future incidents

Without compromising our principle of non-interference with the scientific independence of KOLs and their research findings, Rheon Medical will implement measures to ensure that all future public events related to our technologies remain strictly clinical and scientific in scope.

This expectation will be clearly and explicitly communicated to all future presenters and KOLs. Our messaging will be direct and transparent, and we trust that it will be respected.
